Dropped drain at Pecknall Lane. Clerk is to escalate at Highways
Resurfacing at Back Lane to the Quarry- County Cllr Roberts confirmed this is not in the current schedule but the County Councillors have requested that they are consulted on future schedules – Keep escalating in the meantime that the area between Lower farm and the main road is particularly bad
Pot holes on the road above The Hawthorns – has been raised
Gritting up to Bausley estate – there is no review until Winter 2017 of the program however they have said they will consider the stretch for secondary treatment when it arises.
